

HORNSBY RSL CLUB GUEST WIFI TERMS & CONDITIONS

1. ACCESS

- 1.1 By accepting this agreement and accessing the wireless network, you acknowledge that:
 - (a) You are of legal age;
 - (b) You have read and understood this agreement; and
 - (c) You agree to be bound by this agreement.
- 1.2 The wireless network service is provided by Hornsby RSL Club subject to an internet connection provided to the Club where the WiFi devices are located. Your access is completely at the Club's discretion. Your access to the network may be blocked, suspended, or terminated at any time for any reason.
- 1.3 Your use of the wireless network is completely at your own risk.
- 1.4 You agree not to use the wireless network for any purpose that is unlawful or otherwise prohibited and you are fully responsible for your use.
- 1.5 The wireless network is provided "as is" without warranties of any kind, either expressed or implied, included but not limited to the speed of service.

2. DATA

- 2.1 In order to be granted access to the wireless network you are initially required to login and agree to these terms and conditions.
- 2.2 Hornsby RSL Club may use cookies (a small tracking code in your browser) to improve your experience while browsing, while also sending browsing data back to Hornsby RSL Club. You may manage how your cookies are handled in your own browser settings.
- 2.3 In consideration for your access to the wireless network, you grant Hornsby RSL Club a licence to use your browsing data that Hornsby RSL Club collects (**Data**) for the purposes of marketing the goods and services of Hornsby RSL Club's customers and Venues (**Customers**) to you (including offers and cross-promotion).
- 2.4 Hornsby RSL Club may also de-identify your Data in order to enable analysis by Customers of the datasets owned by, or licenced to Hornsby RSL Club or any purpose.
- 2.5 Hornsby RSL Club may also enrich your Data with data from third party data sources in order to enable analysis by Customers of the datasets owned by, or licenced to Hornsby RSL Club for any purpose.
- 2.6 You agree that Hornsby RSL Club may sub-licence access to your Data to its Customers without further compensation to you.
- 2.7 A Hornsby RSL Club Customer may only use your Data for the same purpose that you supplied it to Hornsby RSL Club to use (i.e. for marketing purposes) and may supply that data to a third party only for the purpose of marketing the relevant Customer's goods or services to you.
- 2.8 Any dispute that may arise in relation to a Customer's use of your data must be dealt with directly between you and the relevant Customer.

3. PRIVACY

- 3.1 Hornsby RSL Club maintains a Privacy Policy in compliance with the provisions of the Privacy Act 1988 (Cth) (**Privacy Act**) for the data that it collects about you, it's Customers and other users. A copy of this policy can be found on the Club's website.
- 3.2 The Privacy Policy does not apply to how a Customer handles personal information. It is the Customer's responsibility to meet the obligations of the Privacy Act by implementing a privacy policy in accordance with law.
- 3.3 Hornsby RSL Club makes no warranty as to whether a Customer's use of your Data complies with the Customer's privacy obligations at law or contract.
- 3.4 Any dispute that may arise in relation to a Customer's use of your personal information must be dealt with directly between you and the relevant Customer.
